

## Student Aid Terms and Conditions

Please read the fine print on this page carefully. You may need to complete several steps to finalize your financial aid award.

**Fontbonne University Scholarships** - Fontbonne University Scholarships are renewable over a maximum of ten semesters (1<sup>st</sup> year students) or six semesters (transfer students) of continuous, full-time, undergraduate, traditional enrollment, or until completion of a bachelor's degree, whichever occurs first. Renewal is contingent upon the student maintaining academic progress.

**Fontbonne Grant** - The Fontbonne Grant is renewable over a maximum of ten semesters (1<sup>st</sup> year students) or six semesters (transfer students) of continuous, full-time, undergraduate, traditional enrollment, or until completion of a bachelor's degree, whichever occurs first. Renewal is contingent upon the student maintaining academic progress.

**Federal Direct Subsidized Loan** - In order to borrow from the Federal Direct Loan Program, you must complete a Federal Direct Loan Master Promissory (MPN) and entrance counseling. Please visit <https://studentaid.gov/> to complete the MPN and entrance counseling. NOTE: You are only required to complete a Federal Direct Loan MPN and entrance counseling once. Disbursements will be made starting after classes start and at certain intervals during each payment period or term (as long as all disbursement requirements are met). Note that subsidized loans will not begin accruing interest until you are no longer enrolled. Loan repayment will begin after a 6-month grace period from when you leave/graduate from the University.

**Federal Direct Unsubsidized Loan** - In order to borrow from the Federal Direct Loan Program, you must complete a Federal Direct Loan Master Promissory (MPN) and entrance counseling. Please visit <https://studentaid.gov/> to complete the MPN and entrance counseling. NOTE: You are only required to complete a Federal Direct Loan MPN and entrance counseling once. Disbursements will be made starting after classes start and at certain intervals during each payment period or term (as long as all disbursement requirements are met). Loan repayment will begin after a 6-month grace period from when you leave/graduate from the University.

**Federal Work-Study** - The Federal Work-Study (FWS) program allows the student to earn up to the amount listed on your award package. FWS compensation is earned when a student performs the work and submits a correct timesheet. Workers are paid bi-weekly as an hourly employee. **Fontbonne Promise** - Students who qualify for Fontbonne Promise will receive a financial aid award that covers full tuition and fees. Fees include new student orientation, course, resource, and graduation fees. Fees do not include items such as textbooks and a parking pass. The scholarship funding will be made possible through a combination of federal aid, state aid, Fontbonne aid and donor contributions. Future funding will depend upon student completing FAFSA by February 1st and there is not a significant change in your expected family contribution. Renewal is contingent upon the student maintaining academic progress.
